- 2001.03 Division of International Studies was established

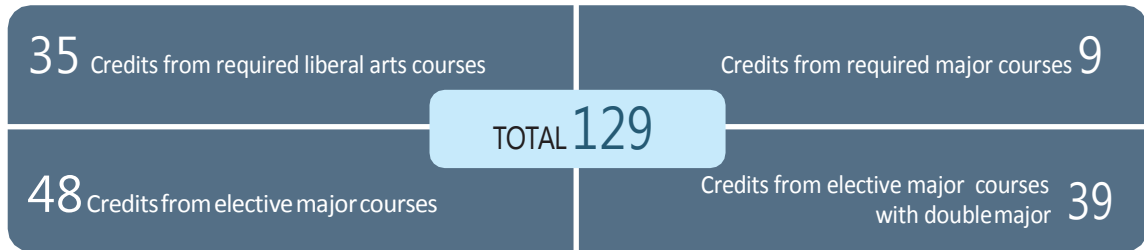
◆ EDUCATION GOALS

◆ International Studies Concentrations

■ Overview: What are the International Studies concentrations?

International Studies Concentrations are NOT required for graduation. However, a certificate will be conferred to those who complete concentration requirements upon graduation. It is issued in the joint name of the DIS Dean and Associate Dean of Scranton College.

- 1) International Business and Economics [BE]
- 2) International Law and Diplomacy [LD]
- 3) East Asian Studies [AS]

■ Requirements

One must complete 18 credits for each concentration to obtain the certificate.

If one selects 2 concentrations and takes one overlapping course in both concentrations, the course may be considered as fulfilling 3 credits for each concentration. An overall GPA of 2.7 is required for graduation with a certificate of concentration.

Global Lecture Series	Scranton College Exchange Student Programs	Ewha-HCAP [Ewha-Harvard College in Asia Program]
<p>“Scranton College Global Lecture Series” are lectures on highly-publicized issues in a variety of academic and professional fields held by notable speakers from within and outside the country. Former speakers include, but are not limited to, Dr. Kyung Chol Park, Professor Jae Chun Choe from Ewha Womans University, Professor Paul Nolte from Free University of Berlin, Dr. Guy Sorman, and Mr. Roger Nord from the International Monetary Fund(IMF). The lectures will help students to develop critical and creative minds and gain global perspectives.</p>	<p>Ewha Scranton College offers students an exchange program with schools that have an exchange agreement with Ewha Scranton College. Students actively participate in the exchange program, and they are recruited in March and September. Tuition fees are paid to Ewha and all the credits received at partner schools can be transferred to Ewha. Exchanges will help students become leaders in the global era.</p>	<p>EWHA-HCAP(Harvard College in Asia Program) is a student-run program at Harvard College. Every year, Harvard College chooses one university in major Asian countries as its partner to understand and confront current issues through two annual conferences. Ewha Womans University has been the first and the only partner university in the nation for the last decade. Other partner universities include University of Tokyo in Japan, St. Xavier’s College in India, American University in Dubai in United Arab Emirates, University of Hong Kong, and Bosphorus University in Turkey. During the conference, students not only discuss and debate about the current issues, but also listen to lectures, visit related sites, and hold cross-cultural exchange programs. Themes change every year. For example, the theme of HCAP 2017 is “Mind, Body, and Society: Global Health Challenges of the 21st Century.”</p>

◆ Club Activities

EDiS	Ewha Debating Society(EDiS) is one of the first English parliamentary debate societies to be established in Korea. Founded in 2002 by Kerry Lee and Pia Kim, EDiS prides itself not only for being a pioneer of debate but also for promoting debate within Korea and the performance of its individual members.
BigInner	To explore the vast field of business studies, the founding members began this student club to gain and teach structural understanding of business in theory and in practice.
DISCO	Founded in 2005, DISCO is the only chamber orchestra composed of International Studies students playing violin, flute, piano, and cello. DISCO performs diverse genres of music from classical to pop music, and plays for many official DIS events as well as various venues outside the university.
VISTA	VISTA is a university webzine in which the ideas and critical perspectives of university students are expressed. The reporters and photographers of VISTA keep track of issues inside and outside of school that are considered important and interesting to the readers.
RIZE	RIZE is the first dance club at Ewha International Studies. Founded in 2006, RIZE has rapidly developed into one of the most popular and active clubs.
ACE	The Academic Consortium for Economics(ACE) is a student-run economics club that aims to provide member students with practical economics and business education.
LAWGIC	LAWGIC is a student law society in International Studies. Its members are diverse, ranging from students seriously preparing for law school to those who are interested in the foundations of law.

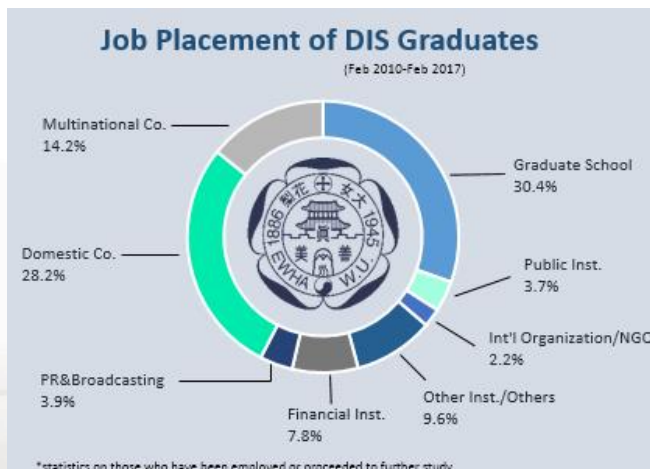
